## Privacy Notice at Walsh Memorial CE Infant School

### (How we use pupil information)

Under data protection law, individuals have a right to be informed about how the school uses any personal data that we hold about them. We comply with this right by providing 'privacy notices' (sometimes called 'fair processing notices') to individuals where we are processing their personal data.

This privacy notice explains how we collect, store and use personal data about **pupils**.

We, Walsh Memorial CE Infant School, Ash Street, Ash, Surrey GU12 6LT, are the 'data controller' for the purposes of data protection law.

Our data protection officer is the School Business Manager (see 'Contact us' below).

### The categories of pupil information that we process include:

- ▣ personal identifiers and contacts (such as name, unique pupil number, contact details and address)
- ▣ characteristics (such as ethnicity, language, and free school meal eligibility)
- ▣ safeguarding information (such as court orders and professional involvement)
- ▣ special educational needs (including the needs and ranking)
- ▣ medical and administration (such as doctors information, child health, dental health, allergies, medication and dietary requirements)
- ▣ attendance (such as sessions attended, number of absences, absence reasons and any previous schools attended)
- ▣ assessment and attainment (such as EYFS, key stage 1 and phonics results,
- ▣ behavioural information (such as exclusions and any relevant alternative provision put in place)

We may also hold data about pupils that we have received from other organisations, including other schools, local authorities and the Department for Education.

### Why we collect and use pupil information

We collect and use pupil information, for the following purposes:

- a) to support pupil learning
- b) to monitor and report on pupil attainment progress
- c) to protect pupil welfare
- d) to provide appropriate pastoral care
- e) to assess the quality of our services
- f) to keep children safe (food allergies, or emergency contact details)
- g) to meet the statutory duties placed upon us for DfE data collections
- h) comply with the law regarding data sharing

Under the General Data Protection Regulation (GDPR), the lawful bases we rely on for processing pupil information are:

We only collect and use pupils' personal data when the law allows us to. Most commonly, we process it where:

- We need to comply with a legal obligation
- We need it to perform an official task in the public interest

Less commonly, we may also process pupils' personal data in situations where:

- We have obtained consent to use it in a certain way
- We need to protect the individual's vital interests (or someone else's interests)

Where we have obtained consent to use pupils' personal data, this consent can be withdrawn at any time. We will make this clear when we ask for consent, and explain how consent can be withdrawn.

Some of the reasons listed above for collecting and using pupils' personal data overlap, and there may be several grounds which justify our use of this data.

### **How we collect pupil information**

We collect pupil information via registration forms at the start of the school year and Common Transfer File (CTF) or secure file transfer from previous school

Pupil data is essential for the schools' operational use. Whilst the majority of pupil information you provide to us is mandatory, some of it requested on a voluntary basis. In order to comply with the data protection legislation, we will inform you at the point of collection, whether you are required to provide certain pupil information to us or if you have a choice in this.

### **How we store pupil data**

We hold pupil data securely for the set amount of time shown in our data retention schedule. For more information on our data retention schedule and how we keep your data safe, please visit [www.walsh-memorial.surrey.sch.uk](http://www.walsh-memorial.surrey.sch.uk)

### **Who we share pupil information with**

We routinely share pupil information with:

- Our local authority – We are required to share information about our pupils with our local authority (LA) and the Department for Education (DfE) under section 3 of The Education (Information About Individual Pupils) (England) Regulations 2013 (Surrey)
- The Department for Education – such data underpins school funding and educational attainment policy and monitoring
- The pupil's family and representatives
- Educators and examining bodies – to enable them to enter pupils into national examinations
- Our regulator Ofsted – to meet our legal obligations to share certain information with it, such as attainment and pupil progress
- Suppliers and service providers – to enable them to provide the service we have contracted them for

- ▣ Health authorities
- ▣ Health and social welfare organisations
- ▣ Professional advisers and consultants – to enable them to provide the service we have contracted them for
- ▣ Charities and voluntary organisations – to enable them to provide funding or activities for families who require assistance
- ▣ Police forces, courts, tribunals – to enable them to protect the child or support the family
- ▣ Professional bodies – to enable them to provide the services we have contracted them for
- ▣ Guildford Diocese of Education

### **Why we regularly share pupil information**

We do not share information about our pupils with anyone without consent unless the law and our policies allow us to do so.

### **Department for Education**

We are required to provide information about pupils to the Department for Education as part of statutory data collections such as the school census and early years census.

Some of this information is then stored in the [National Pupil Database](#) (NPD), which is owned and managed by the Department and provides evidence on school performance to inform research.

The database is held electronically so it can easily be turned into statistics. The information is securely collected from a range of sources including schools, local authorities and exam boards.

The Department for Education may share information from the NPD with other organisations which promote children’s education or wellbeing in England. Such organisations must agree to strict terms and conditions about how they will use the data.

### **Transferring data internationally**

Where we transfer personal data to a country or territory outside the European Economic Area, we will do so in accordance with data protection law.

All data is transferred securely and held by DfE under a combination of software and hardware controls, which meet the current [government security policy framework](#).

### **Requesting access to your personal data**

Under data protection legislation, parents and pupils have the right to request access to information about them that we hold. To make a request for your personal information, or be given access to your child’s educational record, contact The School Business Manager.

If you make a subject access request, and if we do hold information about you or your child, we will:

- Give you a description of it
- Tell you why we are holding and processing it, and how long we will keep it for
- Explain where we got it from, if not from you or your child
- Tell you who it has been, or will be, shared with
- Let you know whether any automated decision-making is being applied to the data, and any consequences of this
- Give you a copy of the information in an intelligible form

Individuals also have the right for their personal information to be transmitted electronically to another organisation in certain circumstances.

If you would like to make a request please contact our data protection officer.

Parents/carers also have a legal right to access to their child's **educational record**. To request access, please contact The School Business Manager.

You also have the right to:

- object to processing of personal data that is likely to cause, or is causing, damage or distress
- prevent processing for the purpose of direct marketing
- object to decisions being taken by automated means
- in certain circumstances, have inaccurate personal data rectified, blocked, erased or destroyed; and
- a right to seek redress, either through the ICO, or through the courts

## How Government uses your data

The pupil data that we lawfully share with the DfE through data collections:

- underpins school funding, which is calculated based upon the numbers of children and their characteristics in each school.
- informs 'short term' education policy monitoring and school accountability and intervention (for example, school GCSE results or Pupil Progress measures).
- supports 'longer term' research and monitoring of educational policy (for example how certain subject choices go on to affect education or earnings beyond school)

## The National Pupil Database (NPD)

Much of the data about pupils in England goes on to be held in the National Pupil Database (NPD).

The NPD is owned and managed by the Department for Education and contains information about pupils in schools in England. It provides invaluable evidence on educational performance to inform independent research, as well as studies commissioned by the Department.

It is held in electronic format for statistical purposes. This information is securely collected from a range of sources including schools, local authorities and awarding bodies.

## Sharing by the Department

The law allows the Department to share pupils' personal data with certain third parties, including:

- ▣ schools
- ▣ local authorities
- ▣ researchers
- ▣ organisations connected with promoting the education or wellbeing of children in England
- ▣ other government departments and agencies
- ▣ organisations fighting or identifying crime

Organisations fighting or identifying crime may use their legal powers to contact DfE to request access to individual level information relevant to detecting that crime. Whilst numbers fluctuate slightly over time, DfE typically supplies data on around 600 pupils per year to the Home Office and roughly 1 per year to the Police.
